John accepted nomination – members present voted and accepted

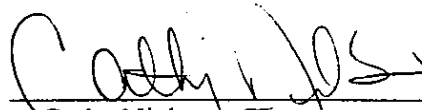
Vice Pres.: Kari Unger nominated Frank Young for Vice President
