

ATTACHMENT TO ARTICLES OF INCORPORATION KING DAVID'S HERITAGE INC. ARTICLE !!! PURPOSE

This corporation is founded exclusively for charitable, religious and educational purposes within the meaning of the IRS Code Sec 501(c)(3); namely: providing courses, seminars, classes, tours, happenings, exhibitions, worship services, religious education, musical events, or any charitable assistance to Jewish persons and other persons who are open to Judaism's message for humanity, be they in the State of Florida, in Israel or elsewhere around the world. This organization will research and teach about the life and meaning of King David and associated concepts as expressed in Scripture, Rabbinic thought and archeology as well teach about as the Jewish concept of the Messiah, its meaning and its influence through history. It will research the significance of Mt Zion in Jerusalem as a Jewish sacred place whereon is located the traditional site of King David's tomb. There it will found and maintain a center or centers for spirituality. This organization will make the results of its research available to the public in the form of articles, books and recordings available on line and through other media. It will provide all manner of life cycle events, including fostering the establishment of cemeteries, and carrying out funerals and burials. It will teach all people about The Seven Universal Commandments given by God to the world. Rabbi Gerald Goldstein has been appointed according to Jewish law to serve as the spiritual head of the organization and the final authority in all matters pertaining to Ethics, Spirituality and Religious Law, including the sole right to determine which questions or issues should be regarded as matters of Ethics, Spirituality and Religious Law.

This corporation shall not, except in an insubstantial way, engage in any activities or exercise any powers that are not in furtherance of its charitable religious purposes. It will not attempt to influence legislation in any way or participate in political campaigns of any sort. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its directors, officers or any private person except that this corporation will be empowered to pay reasonable compensation for services rendered and make purchases of goods or services that are in furtherance of its exempt purposes.

This corporation is empowered to supply all the foods, texts, religious items and physical constructions/properties required according to Orthodox Jewish Law, including Religious Articles, Kosher Food, Places of Worship, Ritual Immersion Pools, Burial Plots or transportation to any event or location which in the view of the Rabbi or Directors is required for the fulfillment of Religious Duties as understood in Jewish Law and Tradition. In the event of this corporation's dissolution, the Board of Directors will, after paying all debts and liabilities, distribute all remaining assets to other corporations recognized by the Internal Revenue Service according to Section 501(c) (3) and which have have similar goals.
