## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF TAMPA BAY ANTIQUE & CLASSIC CAR SHOW, INC.

TAMPA BAY ANTIQUE & CLASSIC CAR SHOW, INC., a not for profit corporation organized and existing under the laws of the State of Florida (the "Corporation"), hereby certifies as follows:

There are no members to vote on this proposed Amendment. Accordingly, pursuant to the approval of the Board of Directors of the Corporation, the following resolutions were adopted on January 28, 2019, amending the Articles of Incorporation:

**RESOLVED**, that Article III of the Articles of Incorporation filed with the Secretary of State of Florida shall be deleted in its entirety and replaced as hereinafter set forth:

#### ARTICLE III

The Corporation is organized exclusively for charitable & educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax 1 code. The Corporation specifically is incorporated to create a car show, open to the public to attend that will display and judge antique and classic vehicles providing sponsors and vendors the opportunity to participate, with proceeds to be donated to a designated charity or charities.

**RESOLVED**, that the Board of Directors deem it in the best interests of the Corporation to include an Article IX, regarding dissolution of the Corporation and the disposition of the Corporation's assets.

#### **ARTICLE IX**

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principle office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**WHEREUPON**, on this 28<sup>th</sup> day of January, 2019, the Corporation has caused its duly authorized officer to execute the Articles of Amendment to the Articles of Incorporation so that, on the filing thereof, the Articles of Incorporation shall be deemed amended accordingly.
