TO  
ARTICLES OF INCORPORATION

Pursuant to the provisions of section 617.1006, Florida Statutes, **Kelly Park Crossing Community Homeowners Association, Inc.**, the undersigned Florida non-profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation.

Article I is deleted in its entirety and the following text is inserted:

**ARTICLE I - NAME**

The name of the corporation is:

In accordance with the Florida Not for Profit Corporation Act, this Amendment shall be effective as of the date of the filing of this Amendment with the Florida Secretary of State.
