**ARTICLES OF INCORPORATION
OF
ENZYME ENVIRONMENTAL PROTECTION & CONSERVATION INC.**

In Compliance with Chapter 617, F.S., (Not for Profit)

**ARTICLE I
NAME OF CORPORATION**

The name of the corporation shall be ENZYME ENVIRONMENTAL PROTECTION & CONSERVATION INC. hereinafter referred to as the Corporation.

**ARTICLE II
PRINCIPAL OFFICE OF THE CORPORATION**

The principal place of business and mailing address of the Corporation shall be 7271 Bee Ridge Rd, Sarasota, FL 34240, US.

**ARTICLE III
PURPOSE OF THE CORPORATION**

This Corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code (the "Code").

The general nature and purpose of the Corporation shall be to promote environmental preservation and sustainable development by mitigating environmental pollution such as neutralizing different kind of environmental problems and harmful chemical toxins in a biodegradation process, to promote animal and wildlife conservation by helping all animals rejuvenate from diseases, infections and environmental disasters, and promote organic enzyme research and development to clean, decontaminate and regenerate green flora and healthy fauna such as to support our ecosystem restoration in an organic way

Except as limited by the Articles of Incorporation and the Bylaws, the Corporation will have and exercise all rights and powers in the furtherance of its purpose as are or may hereafter be conferred on not for profit corporations pursuant to Chapter 617, Florida Statutes, and in accordance with other applicable law.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provisions of these articles, the Corporation shall not carry on

any other activities not permitted to be carried on (i) by a Corporation exempt from federal income tax under Section 501(c)(3) of the Code or (ii) by a Corporation, contributions to which are deductible under Section 170(c)(2) of the Code.
