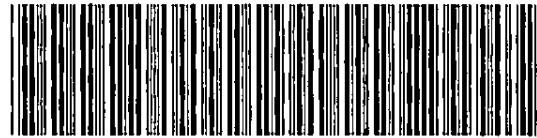

a Florida Not for Profit Corporation**

First: The name of the Corporation shall be **The Foundation for Wealth Building, Inc.**

Second: The place in this state where the principal office of the Corporation is to be located is: 555 W. Granada Boulevard, Suite A2, Ormond Beach, FL 32174

Third: Said corporation is organized exclusively for charitable, religious, educational, research, and scientific purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Our mission is to improve the financial literacy of families and individuals through inspiration and education. Financial literacy is the knowledge that is necessary to make financially responsible decisions about a combination of cash flow, credit and debt management. Improvement in financial literacy has a significant impact on consumers and their ability to provide for their future. The lack of government aid, longer life spans, and more complex choices demonstrate the importance of making thoughtful and informed decisions about finances.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for a public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Sixth: Upon the dissolution of the corporation assets shall be distributed to one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
