

The Executive Board held an emergency meeting today June 22^{nd} , 2024; to discuss and restore damage done to the banking account at Grow Financial Federal Credit Union/ under the name Trinity and Faith Ministry – with assigned EIN# 83-3513510.

A fraudulent document was issued to Grow Financial on Tuesday June18th, 2024 by Deacon Byron Brown, who was relieved from his duties of the church on June 6, 2024 – by the executive board. At the same time the executive board sent a letter to Bishop Michelle B Patty, ending her serve and to cease and descent regarding this church. Byron presented a document to remove and deactivate cards and access of the church accounts assigned to Cherie Benson, and Debra Barrett and to replace them with two others (Felicia Acosta, Javay Macelus); at no time did the Executive Board was knowledgeable about these changes until Debra Barrett was unable to access the account. We will seek legal action against all that presented this fraudulent letter and any attempt to remove funds from the account.

This letter acknowledges that the only authorized appointed Trustees and should have all access to Trinity and Faith Ministry accounts, they are Cherie Benson and Debra Barrett. Please remove any cards and access from anyone other than the two (2) authorized users (Cherie Benson, Debra Barrett). Also please remove the telephone number 813-321-3021; change email address from previous email associated with this account to trinityfaithminstries@yahoo.com (please note spelling). Please shut down all credit cards and re-issue only one(1) to Cherie Benson.


