

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OFORGO DE GRATE MALLO POSILE, FL

SERVING WHERE YOU SERVE, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida Not For Profit corporation adopts the following amendment to its Articles of Incorporation.

- 1. The Name of the corporation is: Serving Where You Serve, Inc. (the "Corporation").
- 2. The date of filing of the Articles of Incorporation of the Corporation was January 18, 2019 and assigned document number "N19000000724".
- 3. The Corporation amends its Articles of Incorporation by amending Article IV to clarify the purpose of the Corporation. Accordingly, Article IV is hereby deleted in its entirety and the following is substituted therefore:

"The Corporation is organized exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code (the "Code")."

4. Except as amended hereby, the Articles of Incorporation shall remain in full force and effect.

These Articles of Amendment to the Articles of Incorporation were approved by the Board of Directors of the Corporation on February 1t, 2019. The number of votes cast in favor of this Amendment was sufficient for approval.
