THE UNDERSIGNED, being of legal age and a natural person, does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

FIRST: The name of this corporation is: Holtzer Inc.

SECOND: This corporation will commence its existence on the date of the filing of these Articles of Incorporation with the Florida Department of State and this corporation will exist perpetually thereafter unless sooner dissolved according to law.

THIRD: This corporation may engage in any activity or business permitted under the laws of the State of Florida.

FOURTH: This corporation is authorized to issue One Hundred shares of common stock to be designated as "common shares". All of said stock will be payable in cash, or payable in property (real or personal), labor or services in lieu of cash, at a just valuation to be fixed by the board of directors of this corporation.

FIFTH: The initial mailing address and principal place of business of this corporation will be 2851 S. Ocean Boulevard, #1E, Boca Raton, Florida 33432 with the privilege of having its offices and branch offices at other places within or without the State of Florida.

EIGHTH: No contract or other transaction between this corporation and any other corporation, and no act of this corporation, will in any way be affected or invalidated by the fact that any of the directors of this corporation are pecuniarily or otherwise interested in, or are directors or officers of, such other corporation. 

TWELFTH: Subject to any subsequent election of directors by the stockholder(s) of this corporation and subject to the subsequent appointment of officers by the director(s) of this corporation, the **sole initial director of this corporation is Robert Holtzer** whose address is 2851 S. Ocean Boulevard, #1E, Boca Raton, Florida 33432 and the initial officers of this corporation are **Robert Holtzer as president and as secretary/treasurer.**




