# ARTICLES OF INCORPORATION FOR NEW JERUSALEM CITY OF GOD CHRISTIAN CENTER, INC.

#### ARTICLE I - NAME AND AUTHORITY

The name of this corporation is New Jerusalem City of God Christian Center, Inc. which originated and was established in Palm Bay, Florida. Its establishment as a religious organization is to be placed under the protection of God and of the Constitution of the United States. This assembly fully believes in the separation of church and state.

# **ARTICLE II - PURPOSE**

Section 1. The purpose for which this corporation is organized is to operate and influence function as a church in all able and educational dimensions including, but not limited to the following purposes:

- A. To advance and promote the worship of God;
- B. To engage in and promote the study of the Bible which is the Word of God:
- C. To advance the gospel of Jesus Christ by preaching, evangelism, teaching and the administration of the ordinances of the church;
- D. To accomplish salvation of the unsaved and to advance the cause of Christ:
- E. To promote biblical principles of justice and righteousness in personal, social, community and national life;
- F. To carry on the work of the church in all its spiritual, benevolent, educational, philanthropic, civil and social life;
- G. To promote the spiritual welfare of all persons and to disseminate the Word of God to people of all nations through evangelistic, educational and charitable sources;
- H. To organize and maintain such ministries and divisions, including, but not limited to, social services and other programs authorized by law which will promote and advance the religious purposes set forth herein.

Section 2. In furtherance of the purposes, and to the extent necessary to carry out such purposes, the corporation:

- 1. Shall have all the powers given to and possessed by a corporation organized under the North Carolina Corporation Act;
- 2. May engage in any lawful activity within the purposes for which the corporation may be organized which are incidental to and in furtherance of the exempt purpose of the corporation; and
- 3. Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from

Federal income tax under Section 501(c)3 of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

# ARTICLE III - GOVERNMENT

The corporation shall have members who shall be accepted, appointed, elected or designated in the manner provided in the bylaws.

#### **ARTICLE IV - MEMBERS**

The corporation shall have members as provided in the bylaws and all members shall be accepted, appointed, elected or designed in the manner set forth in the bylaws. All members shall be of one class.
