

### ARTICLE 1 Name

The name of the Corporation shall be:

Abantika Pivush Shah Foundation, Inc.



# ARTICLE III Purposes

The purposes for which the Corporation is organized and operated shall be:

- A. to qualify and operate as a domestic nonprofit corporation under the Florida Nonprofit Corporation Law (Chapter 617);
- B. to qualify and operate exclusively for charitable, educational, and scientific purposes as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"), or the corresponding section of any future federal tax code;
- C. to qualify and operate as a tax-exempt organization, contributions to which are deductible under Section 170(c)(2) of the Code or the corresponding section of any future federal tax code;
- D. to promote and further traditional Asian Indian Spiritual States in the United States and India;
- E. to support the English translation of rare Asian Indian spiritual books and publications, and to foster teaching of the Vedic language to children in the United States and India:
- F. to promote handicraft skills and self-help programs to support the poor in rural areas of India and to preserve indigenous Asian Indian cultures;
- G. to assist in obtaining and providing clean sources of water, effective health techniques and procedures, and effective education in areas where needed throughout India;
- H. to provide encouragement to Asian Indian performing artists;
- I. to provide educational scholarship, assistance and grants for deserving students of Asian Indian descent for study in colleges or universities in the United States or India.



- J. to provide community assistance and aid to local hospitals and colleges in Bucks County, Pennsylvania, Lehigh County, Pennsylvania, Collier County, Florida, and Lee County, Florida, for those of Asian Indian descent;
- K. to assist old age homes for those of Asian Indian descent, both in the United States and India.

# ARTICLE IV <u>Tax-Exempt Organization</u> Compliance

- A. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.
- B. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
- C. Notwithstanding any other provision of these articles, the corporation shall not carry on any activity not permitted to be carried on by the provisions cited in Article III (A), (B), and (C). Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
