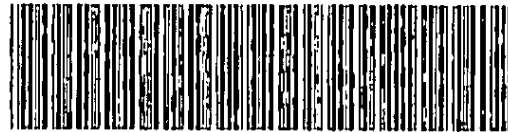

Articles of Incorporation  
for  
YOUTH 2 YOUNG ADULTS, INC.

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation.

Article I: Name

The name of the corporation is: Youth 2 Young Adults, Inc.

Article III: Purpose

Youth 2 Young Adults, Inc. is organized exclusively for charitable and educational purposes that qualify this not-for-profit corporation as an exempt organization under section 501 (c) (3) of the Internal Code or the corresponding section of any future federal tax code. Specifically, the purpose of this not-for-profit corporation is to transform and promote the well-being of at risk youth and young adults by overcoming mental, social and health barriers.

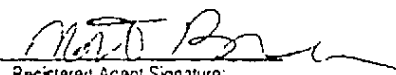

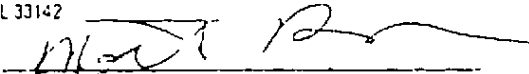

**Article VIII: Limitations on Net Earnings Distribution**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, board members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

**New Article IX: Propaganda**

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

**New Article X: Activity Limitations**

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

*To further clarify, notwithstanding any other provision of these articles, this corporation shall not, except to an unsubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purpose(s) of this corporation.*

**New Article XI: Dissolution of Corporation:**

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Article XII: Amendments**

This Articles of Incorporation has been approved by the entire Board of Directors and their signatures attesting to this approval can be found on page 3 of this document. These Articles of Incorporation may be amended at any regular or special meeting of the Board of Directors by a majority vote of those present; provided that advance notice of the intention to submit amendments at said meeting shall have been given as provided by the bylaws.

**Article XIII: Effective Date for the Articles of Incorporation**

The effective date for this corporation shall be January 25, 2019.
