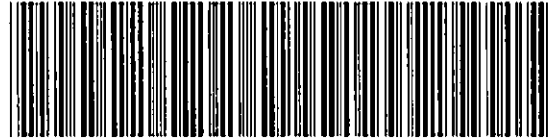

The Promotion of multilingual education for children, where the students learn reading, writing, and arithmetic in English, Spanish, and Chinese.

Said organization is organized exclusively for educational purposes, the making of distributions to organizations that qualify as exempt organizations of distribution to organizations described under Section 501(c)(3) of the Internal Revenue Code or

corresponding section of any future tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.


