Articles of Incorporation Of

Save Our Wetlands.org, Inc (In Compliance with Chapter 617, F.S., Not for Profit)

Article 1.

The name of the corporation is Save Our Wetlands.org, Inc.

Article 2.

The initial registered office of the Corporation shall be at: 17428 SW 36th St. Miramar. FL 33029. The initial registered agent of the Corporation at such address shall be: Mark Morgan.

Article 3.

Article 4.

The initial principal office address of the Corporation shall be at: 17428 SW 36th St, Miramar, FL 33029.

Article 5.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Specific purpose is to preserve wetlands and the wildlife supported within their ecosystems.

Article 6.

The Corporation shall have perpetual duration.

Article 7.

(including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
