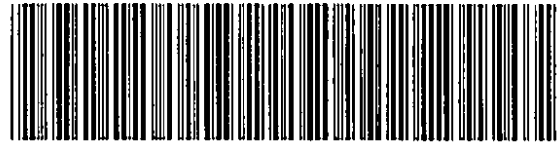

Articles of Incorporation

Article I

NAME

The name of this corporation shall be the PENSACOLA ORGANIC GARDENER'S CLUB, Inc.
The period of duration of the corporation is perpetual.

Article II

Principal Place of Business Address

Article IV

Purpose

4.01 Purpose

Pensacola Organic Gardener's Club, Inc is a non-profit corporation and shall operate exclusively for educational and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal Tax Code. The Pensacola Organic Gardener's Club, Inc purpose is to advance the art of organic gardening by imparting our individual knowledge and experience among our members and the public; shall be to teach people about organic gardening thru lectures, displays at local events and hands on clinics so they can grow better food by cultivating a healthier soil using natural techniques.

4.02 Non-Profit Nature

Pensacola Organic Gardener's Club, Inc is organized exclusively for educational and charitable purposes, including making distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. No part of the net earnings of Pensacola Organic Gardener's Club, Inc shall inure to the benefit of, or be distributed to its members, board of governors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Pensacola Organic Gardener's Club, Inc is not organized and shall not be operated for the private gain of any person. The property of the corporations irrevocably dedicated to its educational and charitable purposes. No part of the assets, receipts, or net earnings of the corporation shall inure to the benefit of, or be distributed to any individual. The corporation may, however, pay reasonable compensation for services rendered, and make other payments and distributions consistent with these Articles.

4.03 Personal Liability

No officer or governing board member of this corporation shall be personally liable for the debts or obligations of Pensacola Organic Gardener's Club, Inc of any nature whatsoever, nor shall any of the property or assets of the officers or governing board members be subject to the payment of the debts or obligations of this corporation.

4.04 Dissolution

Upon termination or dissolution of the Pensacola Organic Gardener's Club, Inc, any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501 (c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation or as a court shall direct.

4.05 Prohibited Distributions

No part of the net earnings, or properties of this corporation, on dissolution or otherwise, shall inure to the benefit of, or be distributable to, its members, governing board, officers or other private person or individual, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

4.06 Restricted Activities

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

4.07 Prohibited Activities

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

4.08 Membership

The admission of members shall be by their payment of dues. Membership shall run from January through December of the current year, with renewal due in January of the following year, with amount of dues to be determined by the Board.

4.09 Amendments

Any amendment to the Articles of Incorporation may be adopted by approval of two-thirds (2/3) of the officers.

Terms run from January thru December of the year following election. There are no limits on number of terms served.
