

RESTATED AND AMENDED ARTICLES OF INCORPORATION OF Social Issues Inc. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

- 1. The name of the corporation is Social Issues Inc.
- 2. The original Articles are being amended and restated. The text of the Amended and Restated Articles is as follows:

<u>ARTICLE I NAME</u>

The name of the corporation shall be: Social Issues Inc.

ARTICLE II PRINCIPAL OFFICE
