#### ARTICLES OF INCORPORATION OF CELEBRATE LIFE ORGANIZATION, INC. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

#### **ARTICLE I NAME**
