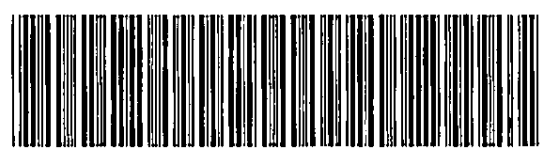



**ARTICLE OF INCORPORATION  
OF

- One:** The name and address of the principal corporation is Palmetto Homes Urban Development Group, Inc., 2010 N.W., 166 Street, Miami, Florida 33054. The corporation is organized pursuant to the State of Florida nonprofit Corporation code.
- Two:** This Corporation is a non-profit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the non-profit public benefit corporation law for charitable and educational purposes. The program (s) will consist of but shall not be limited to: Signal Family Housing; Affordable Housing; Mental Health Living and Services; Assist Living; Alternative Living; Veteran and In mates at high risk; Health Fairs and Intervention; Transitional Housing; Foster Care; Day Care; Community wellness; Training program; Mentorship; After- school program (s) for youth at high risk; Counseling; Housing; Job training and Job placement; Substance Abuse; and other programs to aide those at risk.
- Three:** The duration of this corporation shall be perpetual, shall have no stock and shall have no members.
- Four:** This is to affirm that Tashala Knowles /s/ , 2010 N.W., 166 Street, Miami, Florida 33054 accepted the position as the registered agent of the corporation on February 8, 2019.
- Five:** This corporation is organized and operated exclusively for educational and charitable purposes within the section 501 (c) (3) of the Internal Revenue Code.

Charitable purposes under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a State or Local Government for a disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located , exclusive for such purposes or to such organizations, as said Court shall determine which are organized and operated exclusively for such purposes .
