#### ARTICLE III: AMENDMENT TO THE SPECIFIC PURPOSE

Article III is hereby amended to clarify with specificity that the purpose of the organization is for religious and educational purposes and that at its' core, it is an evangelistic organization with the goal of preaching and teaching the Christian message to churches, para-church groups and other organizations without regard to race, religion, ethnicity, or gender choice. While it is not a church nor affiliated with any denomination, it is more akin to itinerant ministers or traveling evangelistic associations. The ministry can include assisting the poor with food, shelter and clothing as a by product of the teachings as an example to recipients of the messages taught.

ARTICLE IV : Manner in which directors are elected or appointed

Artticle IV is amended to state that Directors are appointed by unanamous consent of the existing directors.

No part of the net earnings of the corporation shall inure to the benefit of, or to be distributable to its members, trustees, officers, or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the exempt purposes as set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in any political campaign on behalf of, or in in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

### ARTICLE X: DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to the state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the country in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
