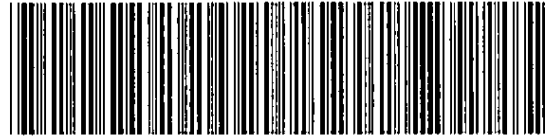


Re: New Horizons of Clewiston INC (N19000001925)
