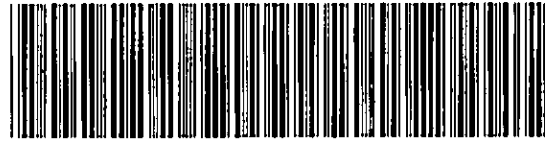

**ATTACHMENT TO THE ARTICLES OF AMENDMENT  
OF  
SACRED SOUL SANCTUARY NATURE SCHOOL CORP.**

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

**First:** The name of the Corporation shall be the SACRED SOUL SANCTUARY NATURE SCHOOL CORP.

**Second:** The place in this state where the principal office of the Corporation is to be located is 11120 Immokalee Road, Naples, Florida 34120.

**Third:** Said corporation is organized exclusively for charitable, religious, educational and/or scientific purposes under Internal Revenue Code section 501(c)(3) or corresponding sections of any future federal tax code.

More specifically, the SACRED SOUL SANCTUARY NATURE SCHOOL CORP. will strive to support in such manner as the Board of Directors determines to be charitable and educational, activities that teach gardening, cooking, nutrition, working with farm animals, yoga, music and basic core classes to underprivileged persons and persons with disabilities. The school focuses on overall wellness and incorporating art into learning.

In carrying out such purposes this Corporation shall have all of the powers and authorities granted by statute and law, including the power and authority to accept gifts, devises and other contributions for charitable purposes either directly or indirectly with other agencies with common goals.

**Fourth:** The Incorporator shall appoint the initial Board of Directors. Thereafter, the Board shall choose its own members by majority vote.

**Fifth:** The names and addresses of the persons who are the initial Board of Directors of the corporation are as follows:

**Sixth:** No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in



Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

**Seventh:** Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**Eighth:** The Registered Agent of the foundation shall be Lohra Ballinger, 11120 Immokalee Road, Naples, Florida 34120.

**Ninth:** I, Lohra Ballinger, the Incorporator, declare that I have examined the foregoing Articles of Incorporation, and that the statements contained herein are, to the best of my knowledge and belief, true, correct and complete. In witness whereof, I have hereunto subscribed my name this 2 day of December, 2019.

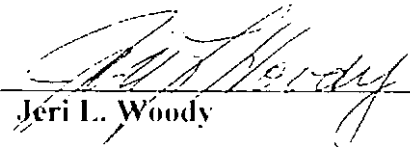
