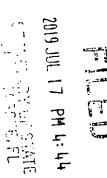

Article Three. General And Specific Purposes

- (a) The specific and primary purpose for this corporation (Synergy Camp, Inc.) is formed to operate for the advancement of children within the community through music educational interaction and for other charitable purposes, by the distribution of its funds for such purposes, and particularly for the development of children within the greater South Florida Area.
