**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF
LAKEVIEW PRESERVE HOMEOWNERS ASSOCIATION, INC.**

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, LAKEVIEW PRESERVE HOMEOWNERS ASSOCIATION, INC., a Florida not-for-profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is Lakeview Preserve Homeowners Association, Inc.
2. The original Articles of Incorporation for the Corporation were filed on February 28, 2019, and assigned Document No. N1900002213.

3. By the execution of a unanimous written consent executed on April 16, 2019, the Corporation's board of directors have approved, authorized, and directed that paragraph 9 and Paragraph 14 of the Corporation's Articles of Incorporation be amended and restated. There are no members entitled to vote on the amendment, and the amendment was adopted by the board of directors.

4. Paragraph 9 of the Articles of Incorporation is hereby amended in its entirety to read as follows:

"9. Board of Directors. The affairs of the Association shall be managed by a Board of odd number with not less than three (3) or more than five (5) members. The initial number of Directors shall be three (3). Board members shall be appointed and/or elected as stated in the Bylaws. After the Turnover Date, the election of Directors shall be held at the annual meeting. The names and addresses of the members of the first Board who shall hold office until their successors are appointed or elected, or until removed, are as follows:

Paragraph 14 of the Articles of Incorporation is hereby amended in its entirety to read as follows:

"14. Officers. The Board of Directors shall elect a President, Vice President, Secretary, Treasurer, and as many Vice Presidents, Assistant Secretaries and Assistant Treasurers as the Board shall from time to time determine. The names and addresses of the Officers who shall serve until their successors are elected by the Board are as follows:
