ARTICLE III – PURPOSE

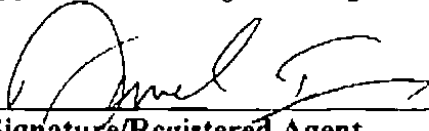
ARTICLE VI – DISPOSITION OF ASSETS UPON DISSOLUTION
