The undersigned, hereby subscribes to and adopts the following as the Amended and Restated Articles of Incorporation (the "Articles") under the laws of the State of Florida, which original Articles of Incorporation were filed on February 27, 2019, with the Florida Secretary of State, Document Number N19000002422:

#### ARTICLE I.

The name of this corporation is Scenic View Storage Condominium Association, Inc., a Florida not for profit corporation (the "Association"). The initial principal office of the corporation is 3724 Taylor Road, Punta Gorda, Florida 33950, and the initial mailing address of the corporation is P.O. Box 510240, Punta Gorda, Florida 33951-0240.

#### ARTICLE II.

The purpose for which this corporation is organized is to act as the governing association of the proposed Scenic View Storage, a non-residential condominium, located in Charlotte County, Florida, and to operate property owned by the Association.

#### ARTICLE III.

The terms used in these Articles of Incorporation shall have the same definitions and meanings as those set forth in the Declaration of Condominium of Scenic View Storage, a non-residential Condominium.

#### ARTICLE IV.

The qualification of members and the manner of their admission shall be as follows: Any record owner of legal title to a condominium unit in Scenic View Storage, a non-residential Condominium, shall by virtue of such ownership be a member of this corporation.

#### ARTICLE V.

This corporation shall exist perpetually. In the event, however, this Association is dissolved, the control or right of access to the property or common elements of the Condominium containing the surface water management system facilities shall be conveyed or dedicated to an appropriate governmental unit or public utility and that if not accepted, then the surface water management system facilities shall be conveyed to a not-for-profit corporation similar to the Association.

#### ARTICLE VI.

  - g. Require all lot owners, parcel owners or unit owners to be members.
