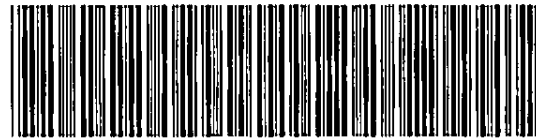

The Foundation is organized exclusively for charitable purposes, including, for such purposes, the making of contributions

to the Foundation that qualify as exempt organizations under section 501(c)3 of the Internal Revenue Code, or corresponding

section of any future Federal tax code additions or amendments."

**ADD ARTICLE IX - DISSOLUTION:**

Upon dissolution of the organization, assets shall be distributed to one or more exempt purposes within the meaning of

section 501(c)3 of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be

ributed to the Federal government, or to a state or local government, for a public purpose. Any such assets not

disposed of shall be disposed of by the Court of Common Pleas in Brevard County, Florida, exclusively for such purposes

or to such organization or organizations, as said Court shall determine, which are organized or operated exclusively for

such purposes.
