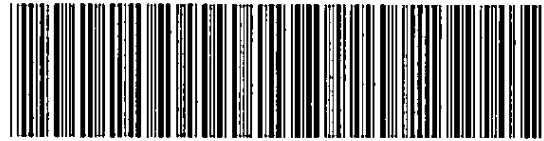

ARTICLES OF AMENDMENT
ARTICLES OF INCORPORATION

I

The name of this corporation is The Pillar of Hope Worldwide Outreach, Inc.

II

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law exclusively for religious purposes.

III

- A. The specific purpose of this corporation is to be a pillar of hope to the local community, nationally and worldwide by spreading the Gospel of Jesus Christ to heal, comfort, educate, and empower the whole man. This corporation is determined to succeed by pursuing any endeavor with spiritual excellence and biblical principals to uplift the body of Christ.
- B. This corporation provides skills enrichment programs that feature segments that assist the youth needing GED, basic education courses, business and technology training. Social services activities ranging from after school tutoring programs, gang intervention and prevention, domestic violence, mental and behavioral health support and family services. In addition, this corporation shall provide alcohol and drug counseling, provide food for the hungry, shelter for the homeless, clothing and refuge for the underprivileged.
- C. This corporation will establish social services programs ranging from after school tutoring, career development, cultural exchange, anger and stress management, recreational opportunities, temporary housing assistance, job training and economic empowerment activities that strengthen the community.

This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

VI


- A. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.
- B. Notwithstanding any other provision of these articles, The organization shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by an organization contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law).

VII

- A. The property of this corporation is irrevocably dedicated to religious purposes and no part of the net income or assets of this corporation shall ever inure to the benefit any director, officer or member thereof or to the benefit of any private person.

VIII

- A. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax-exempt status under IRC section 501(c)(3).


