

ARTICLES OF AMENDMENT ARTICLES OF INCORPORATION 1



The name of this corporation is The Pillar of Hope Worldwide Outreach, Inc.

This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law exclusively for religious purposes.

- A. The specific purpose of this corporation is to be a pillar of hope to the local community, nationally and worldwide by spreading the Gospel of Jesus Christ to heal, comfort, educate, and empower the whole man. This corporation is determined to succeed by pursuing any endeavor with spiritual excellence and biblical principals to uplift the body of Christ.

Social services activities ranging from after school tutoring programs, gang intervention and prevention, domestic violence, mental and behavioral health support and family services. This corporation will establish social services programs ranging from after school tutoring, career development, cultural exchange, anger and stress management, recreational opportunities, temporary housing assistance, job training and economic empowerment activities that strengthen the community.
