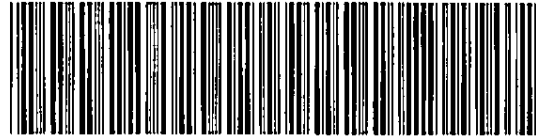

ARTICLE X- PROHIBITED POLITICAL AND LEGISLATIVE ACTIVITY

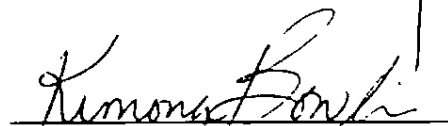
