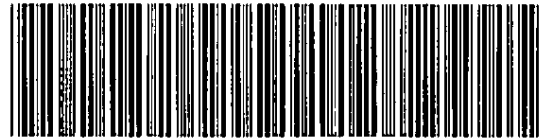

Pursuant to Florida Statute Section 617.1006, the Articles of Incorporation of SARASOTA CHRISTIAN COMMUNITY FOUNDATION, INC. filed on March 8, 2019 and assigned document number N19000002801, are amended to read as follows:

Article 1 of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following new Article 1:


"ARTICLE 1

The name of the Corporation is Manasota Christian Community Foundation, Inc. (the "Corporation")."
