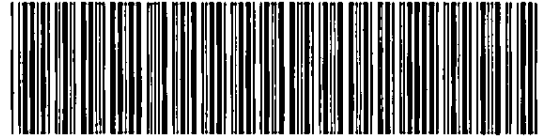

ARTICLES OF INCORPORATION

ARTICLE I. NAME

The name of this not-for-profit corporation shall be HICCUP, Inc.

ARTICLE II. DURATION

The period of duration for this corporation shall be perpetual.

ARTICLE III. PRINCIPAL OFFICE

ARTICLE IV. PURPOSES

HICCUP, Inc. is organized for charitable purposes within the meaning of 501(c)(3). Its goals are: to foster public knowledge and understanding of Cuban American, Cuban, Latino and Spanish-speaking cultures and societies and their imprint in global society, in Hialeah, South Florida, the United States and around the world, and to foster the civic engagement of immigrant, diasporic and Latino populations through arts, culture, and other creative forms, in Hialeah, Miami, South Florida and the United States.

ARTICLE V. POWERS

Powers of the corporation may be limited in accordance with I.R.C. § 501(c)(3) and the accompanying regulations and guidelines.

hiccup will engage in activities permissible under section 501(c)(3), including: promoting and/or conducting research, publishing and other cultural, academic, intellectual, urban and artistic activities, and educating the public on issues related to the culture and society of Cuban and Latin America and U.S. Latinxs, the Spanish speaking world, and their diasporas and/or its impact in the world.

No substantial part of hiccup, Inc. activities will entail carrying on propaganda, or otherwise attempting to influence legislation, except as is otherwise provided by section 501(h) of the Internal Revenue Code. No part of any activities of the organization will include participating in or intervening in any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE VI. FUNDS AND ASSETS, AND DISSOLUTION OF CORPORATION

This corporation shall use its funds only to accomplish the purposes stated in these Articles of Incorporation. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to, and only to, one or

more charitable organizations, as decided at that time by the Board of Directors by a 2/3 majority vote.

ARTICLE VII. APPOINTMENT TO THE BOARD

Directors and Officers shall be appointed after nomination by a member of the board, by a 2/3 majority vote. In no event, shall the number of directors be fewer than three.

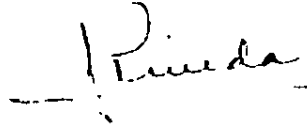

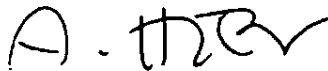
