# Articles of Incorporation of

## The Urban Ore Foundation, Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: My partners and I are OSHA authorized construction safety trainers. As we have been giving classes in telecommunications for the past 15 years. We thought we should do something for the general good. Our idea is to offer a one week course at no cost to opportunity zones, correctional facilities, and active duty/transitioning veterans. The course overview is the first half of the day is into to course and outline, and then we go to a ten hour OSHA course which takes two to three days. We adhere to the OSHA standards for the ten hour course, and everyone who sticks it out receives an OSHA ten hour card for construction at the end of the ten hour safety course at no cost. After completion of ten hour course we have an intro to construction training course. We teach them basic stuff in introduction to construction. We also provide statistics on average first year laborer salary. We want them to realize that there is opportunity within the construction industry for a career. We will also hold a job fair upon course completion for entry level/upper level jobs for all attendants to the course.

No part of the nct carnings of this organization shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of this corporation, assets remaining shall be distributed for one or more exempt purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Competent Jurisdiction of the county in

which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
