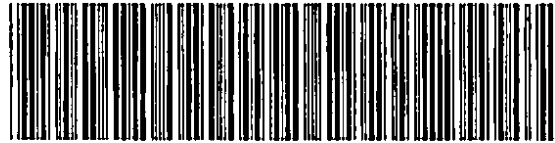

**ARTICLES OF INCORPORATION  
(Not for Profit)  
OF  
CHINESE ACUPUNCTURE FOR VETERANS, INC.**

**Article I – Name**

The name of the Corporation shall be Chinese Acupuncture for Veterans, Inc.

**Article II – Principal Office**

The principal place of business and mailing address of the Corporation shall be:

**Article III - Purpose**

The specific purpose for which this Corporation is organized is to provide acupuncture/acupressure treatments to verifiable United States Military Veterans who are over 65 at no cost or for a nominal fee. In addition, the Corporation will endeavor to host educational seminars and provide demonstrations on the benefits of acupuncture and acupressure for U.S. military veterans at various public venues and locations.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution or winding up of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
