AMENDMENTS ADOPTED

Section 13.2 of the Articles of Incorporation is amended in its entirety to read as follows:

13.2 Adoption. Subject to Section 13.4, a resolution for the adoption of a proposed amendment may be proposed either by a majority of the Board of Directors or by not less than one-third (1/3) of the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their concurrence in writing, provided that such concurrences shall not be used for the purpose of creating a quorum and further provided the approval is delivered to the Secretary at or prior to the meeting. Subject to Section 13.4, approval must be by not less than 55% of the votes of all of the members of the Association.
