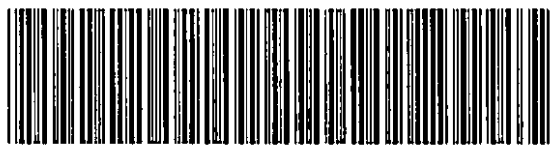

**ARTICLES OF INCORPORATION OF**  
**KHEM TEMPLE NO. 85, DAUGHTERS OF THE NILE CORPORATION**

We, the undersigned Officers, being all citizens of the state of Florida and members of Khem Temple No. 85, Daughters of the Nile, desirous of forming a corporation for charitable, philanthropic and social purposes, under the provisions of Chapter 617 of the Florida Statutes do hereby sign and acknowledge the following articles of incorporation

**ARTICLE I**  
**NAME**

The name of this corporation shall be Khem Temple No. 85 Daughters of the Nile Corporation and its duration shall be perpetual.

**ARTICLE II**  
**LOCATION AND MAILING ADDRESS**

**ARTICLE III**  
**PURPOSE**

The Directors shall be entitled to rely upon the advice of legal counsel, the Accounting Firm and other experts, including financial advisors, and any act of or failure to act by the Directors in good faith reliance on such advice shall in no event subject the Directors or any such other person to liability to the Company or any Member.
