Section 1

Article III

- A. This corporation is organized and operated exclusively for one or more of the following purposes: charitable, educational, scientific and/or religious. This includes the making of distributions to individuals and organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code. This Corporation shall be a nonprofit corporation.
- B. The **specific purpose** of Lion Cubs, Inc is to be a catalyst that expands access and partnerships to underserved populations including youth, low income, veterans, and the elderly in the areas of STEAM (Science, Technology, Engineering, Arts, Mathematics), cyber security, big data, tutoring, mentoring, dietetics (food and nutrition therapy), physical and mental health, and safe/ affordable housing.
- C. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purpose within the meaning of sections 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purpose.
