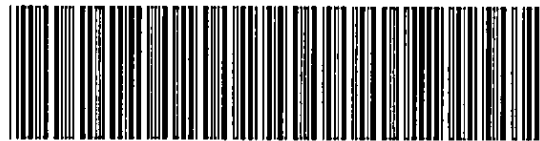

- One:** The name and address of the principal corporation The Briana Green Foundation, Inc., 990 N.W., 202 Street, Miami, Florida 33169. The corporation is organized pursuant to the State of Florida nonprofit Corporation code.
- Two:** This Corporation is a non-profit public corporation and is not organized for the private gain of any person. The corporation is organized under the non-profit public corporation law for charitable and educational purposes. The program (s) will consist of but shall not be limited to: Domestic and International Sport activities and initiatives; Community wellness; Training program; Mentorship; After- school program (s) for youth at high risk; Counseling; Housing; Job training and Job placement; Substance Abuse; and other programs to aide those at risk.
- Three:** The duration of this corporation shall be perpetual, shall have no stock and shall have no members.
- Four:** This is to affirm that Briana Green/*Briana Green* 990 N.W., 202 Street, Miami, Florida 33169 accepted the position as the registered agent of the corporation on February 12, 2019.
- Five:** This corporation is organized and operated exclusively for educational and charitable purposes within the section 501 (c) (3) of the Internal Revenue Code.
- Six:** Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code.
- Seven:** The property of this corporation is irrevocably dedicated to charitable and educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer, or member thereof or the benefit of any private person.
- Eight:** On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a non-profit fund, foundation, or corporation operated exclusively for Educational and. Charitable purposes under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a State or Local Government for a disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located , exclusive for such purposes or to such organizations, as said Court shall determine which are organized and operated exclusively for such purposes .


