**ARTICLE I - NAME**

The name of this not-for-profit Corporation is KID'S CLUB CHILD DEVELOPMENT & EDUCATIONAL CENTER OF BRADENTON, INC.

**ARTICLE II – PRINCIPAL PLACE OF BUSINESS**

The principal place of business and mailing address of the corporation shall be 2015 75<sup>th</sup> Street West, Bradenton, FL 34209,

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any and all lawful activities as and pertaining to a not-for-profit religious organization, to-wit, a non-profit thrift store.

**ARTICLE IV – ELECTION OR APPOINTMENT OF DIRECTORS**

The Directors of the Corporation shall be those persons chosen at the Annual Meeting of the Corporation, at such time and in such manner as more fully set forth in the By-laws of the Corporation.


## **ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT**

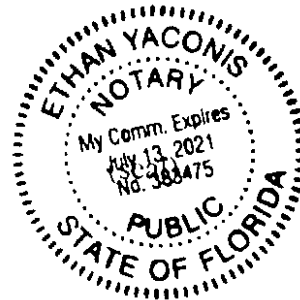


