ARTICLES OF INCORPORATION OF GRACEFULLY GIVING GOOD PEOPLE, INC. A FLORIDA NONPROFIT CORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: Gracefully Giving Good People, Inc.

ARTICLE II PRINCIPAL OFFICE
