ADDITION TO ARTICLE III: PURPOSE

This corporation is organized exclusively for charitable, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code

ARTICLE VIII. ORGANIZATION

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be anything other than activities permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IX. NON STOCK BASIS

This corporation is organized on a non-stock basis. This corporation shall not issue shares of stock.

ARTICLE X. INDEMNIFICATION

The corporation shall indemnify each officer and trustee, including former officers and trustees, to the full extent permitted by the laws of the State of Florida.

ARTICLE XI. DISSOLUTION

Upon the dissolution of the corporation, all remaining assets will be used specifically to further the exempt purpose of this corporation or another exempt organization as described in Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
