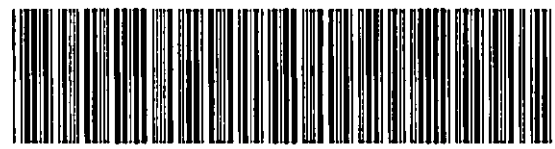

ARTICLES OF INCORPORATION

The undersigned, a majority of whom are citizens of the United States, for the purpose of forming a corporation under the Chapter 607 Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the Corporation shall be: **MOHAMEDRAZA & SHABNUM MOLEDINA FOUNDATION, INC.**

ARTICLE II

DURATION

The duration of the Corporation is perpetual. Upon dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.

ARTICLE III

PURPOSE

A. The general purposes for which the Corporation is organized are the following: It is the mission, duty, and purpose of the MOHAMEDRAZA & SHABNUM MOLEDINA FOUNDATION, INC. to educate our next generation to the Shi'a Ithna-asheri faith of Islam and to provide financial relief to the needy in the United States and in various parts of the world. MOHAMEDRAZA & SHABNUM MOLEDINA FOUNDATION, INC. is organized exclusively for the aforementioned charitable, religious and educational purposes within the meaning of Internal Revenue Code section 501(c)(3), as amended from time to time.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

C. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Article. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV

SPECIAL PROVISIONS

A. This Corporation shall function as a Private Foundation under Section 501(c)(3) of the Internal Revenue Code. As such, the following additional provisions shall govern the Corporation:

1. The Corporation will distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

2. The Corporation will not engage in any act of self-dealing as defined in section 4941(d) of the Internal Revenue Code, or the corresponding section any future federal tax code.

3. The Corporation will not retain any excess business holdings as defined in section 4943(c) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

4. The corporation will not make any investments in manner as to subject it to tax under section 4944 of the Internal Revenue Code, or the corresponding section of any future federal tax code.

5. The corporation will not make any taxable expenditures as defined in section 4945(d) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE V

INITIAL PRINCIPAL OFFICE AND REGISTERED AGENT

In accordance with Florida Statutes, the date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.

ARTICLE X

INDEMNIFICATION

The Corporation shall indemnify each Officer, including any former Officers, to the full extent permitted by law.

ARTICLE XI

DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

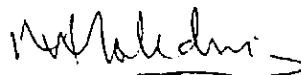

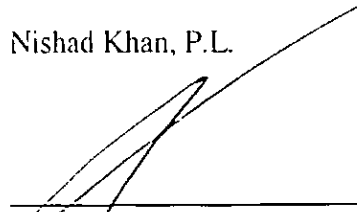
