ARTICLES OF INCORPORATION OF

VERONICA COURT HOMEOWNERS' ASSOCIATION, INC.

(a Florida Corporation not for profit)

In order to form a corporation not for profit, under and in accordance with Chapter of of the Florida Statutes, we, the undersigned, hereby incorporate this corporation not for profit, for the purposes and with the powers hereinafter set forth and to that end, we do, by these Aracles of Incorporation, certify as follows:

The terms contained in these "Articles" are defined in Chapter 720, Florida Statutes, as amended through the date of recording the Declaration amongst the Public Records of Palm Beach County, Florida, shall have the meaning of such terms set forth in such Chapter 720.

ARTICLE I NAME, PRINCIPAL AND MAILING ADDRESS

The name of this Association shall be VERONICA COURT HOMEOWNERS' ASSOCIATION, INC., whose principal and mailing address is: 13969 Veronica Court, Wellington, Florida 33414.

ARTICLE II PURPOSE OF ASSOCIATION

The Purposes for which this Association is organized is to maintain, operate and manage the Homeowners' Association, including the Homeowners' Association Property for the property at Veronica Court, Village of Wellington, Florida being developed by R.P.S. Holding Corp., a Florida corporation ("Developer") and to own portions of, operate, lease, sell, trade and otherwise deal with certain of the improvements located therein now or in the future.

ARTICLE III POWERS

The Association shall have all of the common law and statutory powers of a corporation not for profit, which are not in conflict with the terms of Chapter 720. The Association has the power to assess members for the purposes of the Association including the costs to maintain common areas. The Association has the power to place liens. The Association shall have the power to enter into contracts with governmental entities.

ARTICLE IV MEMBERS

The qualification of members of the Association, the manner of their admission to membership, the manner of the termination of such Membership, and the manner of voting by Members shall be as follows:

- A. Membership in the Association shall be established by the acquisition of ownership of fee title to a Unit or Parcel as evidenced by the recording of a deed or other instrument of conveyance amongst the Public Records whereupon the Membership of the prior Unit or Parcel Owner shall terminate as to that Unit or Parcel.
- B. No Member may assign, hypothecate or transfer in any manner his membership or his share in the funds and assets of the Association.
 - C. With respect to voting, the Association shall have one class of voting membership:

There shall be one vote for each Unit or Parcel and the vote shall be cast by the owner(s) of the Unit or Parcel.

- D. All members are subject to assessments for the purposes of the Association and after turnover the Developer shall pay assessments on Units or Parcels still owned.
- E. Any member may petition the appropriate court for the appointment of a receiver to manage the affairs of the corporation in the event of dissolution of corporation.

ARTICLE V TERM

The term that this Association is to exist shall be perpetual.

C. Directors must be Members or the spouses, parents or children of Members, except that if a Dwelling Unit is owned by an entity and not an individual, such entity may appoint two individuals on its behalf to be eligible to serve on the Board of Directors.

ARTICLE VII POWERS AND DUTIES OF THE BOARD OF DIRECTORS

All of the power and duties of the Association shall be exercised by the Board in accordance with the provisions of Chapter 720 and the Homeowners' Association Documents.

ARTICLE VIII INDEMNIFICATION

Every Director and Officer of the Corporation shall be indemnified by the Corporation against all expenses and liability, including attorneys' fees, reasonably incurred by or imposed upon him in connection with any proceeding to which he may be a party or in or in which he may become involved by reason of his being or having been a director or officer, whether or not he is a director or officer at the time such expenses are incurred, except in such cases where the director or officer is adjudged guilty of willful misfeasance or malfeasance in the performance of his duties, provided however, that in the event of any claim for reimbursement or indemnification hereunder based upon a settlement by the director or officer seeking such reimbursement or indemnification, the indemnification herein shall apply only if the Board approves such settlement and reimbursement as being in the best interest of the Corporation. The foregoing right of indemnification shall be in addition to but not exclusive of all other rights to which such officer or director may be entitled.

ARTICLE IX BYLAWS

The Bylaws of the Association may be altered, amended or rescinded by the affirmative vote of not less than a majority of the Members present at an Annual Members' Meeting or special meeting of the membership and the affirmative approval of a Majority of the board at a regular or special meeting of the Board. In the event of a conflict between the provisions of these Articles and the provisions of the Bylaws, the provisions of these Articles shall control.

ARTICLE X BOARD OF DIRECTORS

- A. The number of initial directors on the Board of Directors shall be four (4). The number of Directors elected by the Members at and subsequent to the Majority Election Date shall be as provided in Paragraph C and D of this Article VII.

Directors must be Members or the spouses, parents or children of Members, except that if a Dwelling Unit is owned by an entity and not an individual, such entity may appoint two individuals on its behalf to be eligible to serve on the Board of Directors.

- D. The following provisions shall govern the right of each Director to vote and the manner of exercising such right:
 - 1. There shall be only one (1) vote for each Director.
 - 2. In the case of deadlock by the Board, application shall be made to a court of competent jurisdiction to resolve the deadlock.

ARTICLE XI POWERS AND DUTIES OF THE BOARD OF DIRECTORS

All of the power and duties of the Association shall be exercised by the Board in accordance with the provisions of Chapter 720 and the Homeowners' Association Documents.

ARTICLE XII AMENDMENTS

These Articles may be amended by an instrument in writing signed by the President (or a Vice President) and the Secretary (or an Assistant Secretary) and filed in the Office of the Secretary of State of the State of Florida. The instrument amending these Articles shall identify the particular Article or Articles being amended, give the exact language of such amendment and give the date of a adoption of the amendment by the Board. A certified copy of each such amendment shall always be attached to any certified copy of these Articles or a certified copy of Articles as related to include such Amendments and shall be an exhibit to each Declaration upon the recording of each Declaration. This Article XI is intended to comply with Chapter 617, Florida statutes.
