#### ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 617.0202 of the Florida not-for-profit Corporation Act, the undersigned foundation adopts the following Articles of Incorporation:

### ARTICLE I Name

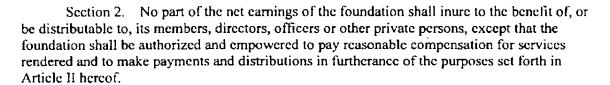
### ARTICLE VIII Amendment

### ARTICLE IX Restrictions and Interpretation

Section 1. This foundation shall distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Code. Further, this foundation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Code, nor retain any excess business holdings as defined in Section 4943(c) of the Code, nor make any investments in such manner as to incur tax liability under Section 4944 of the Code, nor make any taxable expenditures as defined in Section 4945(d) of the Code.



- Section 3. No substantial part of the activities of the foundation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the foundation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- Section 4. Notwithstanding any other provision of these Articles of Incorporation, the foundation shall not carry on any other activities not permitted to be carried on (a) by a foundation exempt from Federal income tax under Section 501(c)(3) of the Code or (b) by a foundation, contributions to which are deductible under Section 170(c)(2) of the Code or by a nonprofit foundation organized under the laws of the State of Florida pursuant to the provisions of Chapter 617, Florida Statutes.
- Section 5. It is intended by the provisions of these Articles of Incorporation that the foundation shall possess the status of an organization exempt from federal income taxation under the provisions of Section 501(c)(3) of the Code as now in force or hereafter amended. Accordingly, no part of the affairs of this foundation shall be administered, directly or indirectly, in any manner whatsoever which might jeopardize the tax-exempt status of this foundation.

#### ARTICLE X Dissolution

Upon the dissolution of the foundation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the foundation, dispose of all of the assets of the foundation exclusively for one or more of the purposes of the foundation which may include distribution to an organization or organizations organized and operated exclusively for one or more of such purposes, or shall distribute all of the assets of the foundation to the federal government, or to a state or local government for a public purpose. Any such assets not so disposed of shall be disposed of by the circuit court of the county in which the principal office of the foundation is then located, exclusively for such purposes or to such organization or
