



Part E attachment - Amending and adding additional Articles

Dated 11/1/2019, the following Amendment to Article III of the Articles of Incorporation supersedes any previous amendments and the initial purpose statement when the Articles of Incorporation were initially created on 4/14/2019. Additionally, Part E of the Articles of Amendment that were filed on 5/7/2019 (which began with, "Donate yoga expands Peace & Love around the world through Yoga...") is to be replaced as well by the new amendment listed below.

Amendment to Article III 11/1/2019 - The specific purpose for which this corporation is organized.

The organization, Donate Yoga Inc. is organized exclusively for charitable, and educational purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. This includes, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code.

Additional Article IX. - Dissolution Clause

Upon the dissolution of this organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

Additional Article X. - Mission Statement

Donate yoga's mission is to celebrate diversity, strengthen communities, and encourage peace, through our national network of yoga professionals who donate free yoga, meditation, and wellness events to underserved communities across the USA.
