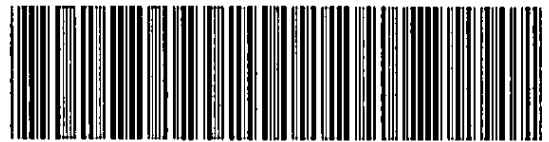

ARTICLES OF INCORPORATION
In compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I. NAME.

The name of the corporation shall be BRIDGES CHRISTIAN LEARNING CENTER, INC.
(hereinafter referred to as "BCLC, Inc." and/or the "Corporation").

ARTICLE II. PRINCIPAL OFFICE and MAILING ADDRESS.

The Principal street address for the Corporation is:

7430 Belvedere Road, West Palm Beach, Florida 33411.

The Mailing address for the Corporation is:

125 S. State Road 7, Suite 104-#413, Wellington, Florida 33414.

ARTICLE III (A): PURPOSE.

BRIDGES CHRISTIAN LEARNING CENTER, INC., is a not-for-profit educational organization providing individual instruction to develop or improve capabilities, including teaching, tutoring, educational therapy, academic support and small class sizes with low teacher-student ratios to foster success in students from elementary to high school and beyond in a nurturing environment that embraces Judeo-Christian values; said corporation is organized exclusively for educational purposes.

ARTICLE III (B): DEDICATION OF ASSETS.

The properties and assets of this not-for-profit Corporation are irrevocably dedicated to educational purposes. No part of the net earnings, properties, or assets of this Corporation, on dissolution or otherwise, shall inure to the benefit of any private person or individual, or any member, director or officer of this Corporation. On liquidation or dissolution, all properties and assets, and obligations if any, shall be

distributed and paid over to an organization dedicated to similar charitable, religious and/or educational purposes, which has established its tax-exempt status under Internal Revenue Code Section 501(c)(3).

ARTICLE IV: BOARD OF DIRECTORS MANNER OF ELECTION, NUMBER.

ARTICLE IV(A): ELECTION. All directors shall be selected as provided for in the Bylaws.

ARTICLE IV(B): NUMBER OF DIRECTORS. The number of directors may be increased or decreased from time to time by amendment to the Bylaws; however, there shall be no less than three (3) and no more than (12) directors, at any given time.

ARTICLE V: INITIAL OFFICERS AND/OR DIRECTORS

The officers of the Corporation shall be the President, Vice President, Secretary, Treasurer, and such other officers as may be provided by the Bylaws. The initial Board of Directors shall consist of eight (8) persons, as follows:
