Articles of Incorporation Of

(In Compliance with Chapter 617, F.S., Not for Profit)

Article 1.

The name of the corporation is Centurion Medical Missions. Inc.

Article 2.

The initial registered office of the Corporation shall be at: 2561 Rescue Way. Brooksville, FL 34601. The initial registered agent of the Corporation at such address shall be: William Honeyeutt.

Article 3.

The name and address of the incorporator is:

Article 4.

Article 5.
