ARTICLES OF INCORPORATION OF THE LIMITLESS FOUNDATION, INC. (NOT FOR PROFIT)

The undersigned incorporator, for the purpose of forming a Florida not for profit corporation under the provisions of the Florida Not For Profit Corporation Act, does hereby execute the following articles of incorporation:

- 1. NAME. The name of the corporation is The Limitless Foundation, Inc.
- 2. INITIAL PRINCIPAL OFFICE. The street address of the initial principal office of the corporation is 9221 Bayway Drive, Orlando, Florida 32819.
- 3. **PURPOSES.** The purpose or purposes for which the corporation is formed are: to be organized and operated exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. In furtherance of such exempt purposes, the corporation's mission is to initiate and support community-based programs that promote education, health and social skills of underprivileged and underserved communities, especially children.
 - 4. **DURATION.** The duration of the corporation is perpetual.
- 5. **DIRECTORS.** The affairs of the corporation shall be managed by a Board of Directors at all times consisting of at least three (3) individuals. The manner in which directors are elected and appointed is as provided for in the corporation's bylaws.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of the corporation set forth herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this instrument, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
