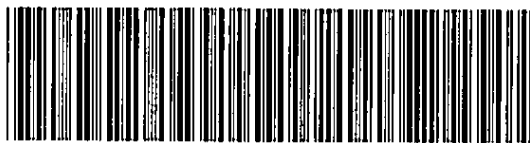

**ARTICLES OF INCORPORATION  
FOR LAKE HOWELL HIGH SCHOOL ATHLETIC BOOSTER CLUB, INC.**

The undersigned incorporators are individuals 18 years of age or older and adopt the following articles of incorporation to form a nonprofit corporation.

**ARTICLE I  
NAME**

The name of the corporation shall be LAKE HOWELL HIGH SCHOOL ATHLETIC BOOSTER CLUB, INC. ("LHHS ABC").

**ARTICLE II  
CORPORATE EXISTENCE AND DURATION**

The corporate existence of LHHS ABC shall commence upon the date of the subscription and acknowledgment of these Articles of Incorporation pursuant to Florida Statute 617. The period of its duration is perpetual.

**ARTICLE III  
STATEMENT OF PURPOSE**

LHHS ABC shall be a Florida nonprofit organization incorporated exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code and Chapter 617 of the Florida Statutes.

The objective and purpose of LHHS ABC shall be to promote and encourage all athletic programs at Lake Howell High School including:

- A. To assist, cooperate with and support all athletic teams of LHHS ABC.
- B. To encourage and foster student and community interest in all Lake Howell High School athletic activities.
- C. To raise funds to be utilized for supporting the student athlete and athletics program at Lake Howell High School in accordance with state and federal law and the Internal Revenue Code.
- D. To abide by all local, state and federal laws rules, regulations, codes and decisions promulgated for enforceable against and related to not-for-profit corporations.

**ARTICLE IV

**ARTICLE VIII  
INUREMENT AND INCOME**

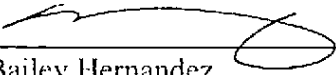
No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

**ARTICLE IX  
DISSOLUTION**

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of by the court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

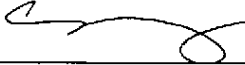
