

## TCHMI - Plan of Dissolution

DATE: December 8, 2024

The Carpenter's Hand Missions, Inc., herein referred to as the company, board of directors voted unanimously on December 8, 2024 to dissolve the company that was incorporated on April 30, 2019 in the State of Florida. The dissolution is effective no later than December 31, 2024. The board of directors are Randy Talcott, Tonja Talcott and Diane Padgett.

The decision for dissolution was approved on December 8, 2024 and that the company will wind up all affairs by December 31, 2024. The reason for dissolution was due to the company having fulfilled its intended purpose and mission, therefore, needed to be dissolved.

The company does not have any shareholders. Randy Talcott, President, will contact creditors to pay outstanding balances prior to closing out the company's only Synovus business bank account. The company has two creditors, a Citi AAdvantage Business Credit Card and a Sam's Club Credit Card. The company has one WIX website and one Straight Talk wireless account. The company has one PO Box subscription. No other creditors or liabilities are known to exist.

The company has no inventory and no non-monetary assets. The company has no outstanding contracts. The company has no disputed claims. The company has made no further commitments and does not anticipate having any unclaimed liability or distributions.

WIX website has subsequently been closed and all debt has been settled.

Straight Talk wireless has subsequently been closed and all debt has been settled.

Citi AAdvantage Business Credit Card will be closed no later than 12/31/24 and all debt will be settled.

The PO Box subscription has been paid through 6/30/2025. To ensure any and all necessary correspondence continues to be delivered, the company will close the PO Box subscription, after any future mail has been forwarded to 2646 Springtime Court, Gulf Breeze FL 32563, or before the subscription renews in July 2025.

The balance of any monetary assets in the Synovus business bank account will be assigned to a non-profit organization called My Father's Arrows located in Jay FL. My Father's Arrows has a similar mission to the company.
