ARTICLES OF INCORPORATION
FOR
THE RACONTEUR GUILD, INC.

ARTICLE I
NAME

The name of the corporation is The Raconteur Guild, Inc.

ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal office and mailing address is 4560 Pinewood Avenue, Jacksonville, Florida 32207.

ARTICLE III
COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of the filing of these Articles of Incorporation.

ARTICLE IV
PURPOSE

The corporation is formed exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding Section of any future federal tax code (the "Code"). Principally, the corporation is formed to promote a better understanding of our history, our future, and one another, by uniting, enlightening and educating through the crafts of storytelling, using literature, visual and performing arts. To support this purpose, the corporation will produce films, podcasts and other sources of media to be provided to the public. The corporation will sponsor, host and/or participate in events that promote the craft of storytelling. The corporation may engage in any activity or business permitted under the laws of the United States and Florida, as permitted by an organization exempt from the payment of taxes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

ARTICLE V
BOARD OF DIRECTORS

Section 1.1 The concerns, direction and management of the affairs of this corporation shall be vested in the Board of Directors. This corporation shall have no members.

Section 2.1 The Board shall at all times consist of at least three (3) directors and may have such additional directors as provided in the Bylaws of the corporation.

Section 3.1 The method of electing directors shall be set forth in the Bylaws of the corporation.

ARTICLE VI. ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its directors or officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make to payments and distributions in furtherance of the purposes set forth in Article IV above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, the corporation shall not carry on any other activities not permitted to be carried on (i) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code, or (ii) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Code.

ARTICLE VII DISSOLUTION

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or shall be distributed to the federal government, or to a state or local government, for public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said court shall determine which are organized and operated exclusively for such purposes.

**ARTICLE VIII
INITIAL REGISTERED OFFICE AND AGENT**

**ARTICLE IX
